Sub: Provisional Selection of candidates for the 2-year MPH Programme at ICMR-NIE,
Chennai, commencing in July 2024 – Reg.

We are pleased to inform that the candidates shown in the Selection list (Annexure- 1)
have been selected for the India FETP-Master of Public Health (MPH) Programme for the
academic session commencing on July 2024 (July 2024 to June 2026).

The selection of the candidates is/are subject to the following conditions:

1. The candidates should be deputed to ICMR-NIE on full time basis for a period of two years from the date of commencement of the course, i.e. **1st July 2024**.
2. Presence of the candidate at ICMR-NIE on the date of commencement of the programme
3. Submission of relevant certificates/documents in original (MBBS, Higher degree (if any), Registration with Medical Council of India, Proof for age, etc.,) for verification
4. Submission of Community certificate (in original for verification) from an officer not below the level of Tehsildar, in case of SC/ST/OBC/PH candidates

For sponsored Government candidates

5. Payment of salary for the candidates by the sponsoring State Government
6. Submission of sponsorship letter from the employer **on or before 1st June 2024**, if not submitted already
7. **This offer for admission will stand cancelled automatically, if sponsorship letter is not received by ICMR-NIE by 1st June 2024**

Course Fee


8. **There is no course fee for the candidates deputed by the State/Central Government Departments/Armed Forces.**
9. **One time Administrative Services fee Rs. 30,000/- to be paid at the time of admission to SCTIMST by both the deputed and non-deputed candidates.**
10. **For the non-deputed government/private candidates and the deputed candidates from private institutions, the course fee is Rs. 1,00,000/- (Rupees One lakh only) (non-refundable), payable at the beginning of the course.**

Candidates shall submit their **willingness for joining** the course and intimation regarding requirement of accommodation in the ICMR-NIE Hostel **on or before 15th April 2024** by email to icmrniesph@nie.gov.in. Accommodation at ICMR-NIE will be provided on payment basis as per ICMR rules.

We request you to kindly arrange to depute the selected candidate/s from your State to ICMR-NIE for the India FETP-MPH programme, to enable him/her/them to report at ICMR-NIE, Chennai, no later than 1st July 2024.
