With reference to the ICMR-NIE Advertisement No. ICMR-NIE/Tech.Recruit/2023 dated 25.09.2023, the candidates are advised to note the following:

1. The online registration link for filling up of Technical Assistant and Laboratory Attendant-I is https://joinicmr.in/login/user. The important dates for online registration, printing of hall tickets and conduct of CBT exam are furnished below:

2. Identification of posts under PwBD at ICMR-NIE, Chennai

With reference to the Page No. 04 of the advertisement, it is mentioned that *One post each* in Technical Assistant and Laboratory Attendant-1 is reserved for Persons with Benchmark Disabilities (PwBD) in the category of Loco-motor disability including cerebral palsy, leprosy cured, dwarfism, acid attack vicitims and muscular dystrophy.

After due deliberations, we have identified the posts for PwBD and the Horizontal Reservation for PwBD has been fixed as follows:

3. Provision of Compensatory Time and assistance of scribe:

- 3.1 In case of persons with benchmark disabilities (PwBD) in the category of blindness, locomotor disability (both arms affected-BA) and cerebral palsy, the facility of scribe is provided, if desired by the candidate.
- 3.2 The facility of scribe will also be provided to PwD candidates having disability less than 40% and having difficulty in writing in pursuance to OM No. 29-6/2019- DD-III dated 10.08.2022 issued by Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment. The facility will be provided on production of certificate as per Annexure-IA.
- 3.3 The facility of scribes/ passage reader will be provided to the PwBD/ PwD candidates only if he has opted for the same by communicating to this office.
- 3.4 The candidate will have the discretion of opting for his own scribe or to avail the facility of scribe provided by the Institute. Appropriate choice in this regard will have to be given by the candidate by way of communication.
- 3.5 In case the candidate opts for his own scribe, the qualification of the scribe should be one step below the qualification of the candidate taking the examination. The candidates with benchmark disabilities (PwBD) opting for own scribe shall be required to submit details of the own scribe at the time of examination as per Proforma at Annexure-II(A & B). In addition, the scribe has to produce a valid ID proof [as per list given at para-3.11] in original at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe will also be submitted. If subsequently it is found that the qualification of the scribe is not as declared by the candidate, then the candidate shall forfeit his right to the post and claims relating thereto.
- 3.6 If a candidate opts for his own scribe, in that case, that scribe should not be a candidate of this examination. If a candidate is detected as assisting another PwBD/ PwD candidate as scribe in this examination, then the candidatures of both the candidates will be cancelled.
- 3.7 A compensatory time of 20 minutes per hour of examination will be provided to the persons who are allowed use of scribe as per above paras.
- 3.8 The candidates referred at paras above, who are eligible for use of scribe but not availing the facility of scribe will also be given compensatory time of 20 minutes per hour of examination.
- 3.9 No attendant other than the scribe for eligible candidates will be allowed inside the Examination Hall.
- 3.10 The PwBD/ PwD candidates who have availed the facility of scribes/ passage reader and/ or compensatory time must produce relevant documents for the eligibility of scribe/

compensatory time at the time of Document Verification. Failure to produce such supporting documents will lead to cancellation of their candidature for the examination.

- 3.11 The list of valid ID Proof:
 - Aadhaar Card/ Printout of E-Aadhaar
 - Voter's ID Card
 - Driving License
 - PAN Card
 - Passport
 - Employer ID Card (Govt./ PSU)
 - Ex-Serviceman Discharge Book issued by Ministry of Defence
 - Any other photo bearing ID Card issued by the Central/ State Government.
- 3.12 The PwBD candidate requires scribe either by the nomination of examination Institute or by own, he/she should submit the prior intimation of the request / relevant certificates prescribed in the para no. 3.5 to the following address by post / email for making appropriate arrangements.

4. Additional weightage of marks for post essential qualification experience:

With reference to the ICMR Letter No.16/28/2023/Admn. Dated 11.08.2023, it is informed that the competent authority of ICMR had decided that upto 5 marks will be accorded to candidates who possess Post Qualification research / lab / field experience in any Government recognized/approved / registered Institution or Organization. This marks will be added to the marks scored by the candidate in the Computer Based Test (CBT). The marks are to be awarded as follows:-

Relevant Experience	Weightage (marks)
> 1 and upto 2 years	1
> 2 and < 4 years	2
> 4 and < 6 years	3
> 6 and < 8 years	4
>= 8 years	5

Hence, the candidates who possess the appropriate post essential qualification experiences are instructed to choose the option for availing the additional weightage criteria while filling up the online application.
