Interested bidders are required to sign "Bid Security Declaration" accepting that if they withdraw or m odify their Bids during the period of validity, or if they are awarded the contract and they fail to sign th e contract, or to submit a performance security before the deadline defined in the request forbids doc ument, they will be suspended for the period of 1 year from being eligible to submit Bids for contracts with the entity that invited the Bids.

(b) If the Equipment is not commissioned and handed over to the consignee within 3 months, th e insurance will be got extended by the supplier at their cost till the successful installation, testing, co mmissioning and handing over of the goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the site to the supplier by the consignee, such extensions of t he insurance will still be done by the supplier, but the insurance extension charges at actual will be re imbursed. (c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be insured in favour of the Director, ICMR-National Institute of Epidemiology, Chennai, covering all risk s basis for the goods from supplier/ manufacturer warehouse to consignee warehouse.
